

GVYRS Every Coach Certified Requirements

- 1. Register as a member with Rowing Coach under the role of coach / volunteer. Please select GVYRS.
 - a. Link: https://membership.rowingcanada.org/Home
 - **b.** Each year you will have to re-register with your club to maintain up to date records.
- 2. Confirm you have completed a criminal record check through sterling back check or with your local RCMP. While each school is responsible for administration, please also confirm with the GVYRS Coach Developer board member (coachdevelopment@gvyrs.ca). by copying and pasting the checklist below.

- 3. Confirm you have completed your Pleasure craft operator course. Please send a screenshot of your license to coachdevelopment@gvyrs.ca.
- 4. Complete Coach Initiation in Sport through the NCCP locker:

 - d. Time to complete: 30 minutes
- 5. Complete Rowing Essentials: Rowing essentials is found through the locker in the sport specific rowing section of the e-learning page.

 - b. Cost: 20\$
 - c. Time to complete: 45 minutes
- 6. Complete Making Ethical Decisions (MED). MED online evaluation can be done through an e-learning section in the locker. The MED module can be done through ViaSport (https://www.viasport.ca/coaching/make-ethical-decisions) or via a workshop hosted by Rowing BC. The GVYRS Coach Developer will send out periodic updates on MED workshops for coaches to attend prior to the beginning of school season.

 - c. Cost: 80\$
 - d. Time to complete: 3 hours + evaluations



Notes:

- 1. Every person who coaches athletes on water must complete the items listed above
 - a. Teacher sponsors who are administrators only (do not coach) are not required to complete Every Coach Certified.
- If you have your Level 1 or Level 2 Rowing Canada certification, you are **NOT** required to do Coach initiation in sport or rowing essentials however you **ARE required** to do Making Ethical Decisions module and online evaluation.
 - a. Note: the evaluation can be challenged without attending the module. Participants have up to 2 attempts to achieve a score of 75% or higher to pass the MED course.
- 3. There are a couple of approaches to getting this all paid for. First and preferred option is to get reimbursed by the school you will be coaching for. If that is not successful, half of your coach certification fees will be covered by GVYRS. The other half may be covered by VCRC or GNRC if you have intent to coach at these clubs beyond the school season. Historically, the club you will coach at will cover the half of the coach certification costs.
